

# **TUITION AND FEE POLICY**

#### Annual Tuition and Curriculum Fees

Grammar School Tuition (K-6)	\$7,000	Grammar Curriculum Fees	\$300
Logic School Tuition (7-8)	\$7,000	Logic Curriculum Fees	\$400
Rhetoric School Tuition (9-12)	\$7,000	Rhetoric Curriculum Fees	\$450

Fees do not include uniforms, classroom supplies, or field trips.

#### **Tuition Payment Options**

Tuition Paid Annually	Due July 5, 2025	\$7,000
Tuition Paid Semi-annually	Due July 5, 2025 & January 5, 2026	\$3,500
Tuition Paid Monthly	Due the 5th of each month for 12 months	\$583.33

Curriculum fees are due by March 4, 2025. For those enrolling after March 4, the payment will be required at the time of enrollment. Please note that curriculum fees are non-refundable.

## Adjustment to Enrollment Schedule

Since Trinity Classical School must make budgetary decisions based on a projection of enrollment, purchase supplies and materials, and contracts with teachers and staff based on enrollment agreements, the school retains a prorated portion of tuition if a family must withdraw before/during the school

year.



When a student is withdrawn from school, the parent's financial liability for tuition is shown below. When a student enters mid-year, tuition is prorated according to the Delayed Entry schedule below.

## **Tuition Assitance**

Trinity Classical School partners with BeneFAQs Financial Aid Qualification to manage tuition assistance applications and determine award amounts. You can email the TCS office for a link to the application. There is a \$35 fee per family to apply. The Trinity Trust Fund Committee reviews BeneFAQs' recommendations, which are based on a thorough process that includes paystubs and the most recent tax information. Financial need is calculated as the gap between your family's resources and the cost of tuition, with Trinity striving to meet a portion of that need, though full coverage cannot be guaranteed. Please email the TCS office for an application link. All applications are due by April 15, 2025 to be considered.
